Cancellation/Refund Policy:

Applicants may push the school start date to a later date with no loss of deposit.

A student may cancel his/her enrollment prior to the first day of their program as outlined on their Enrollment Agreement. The-\$750.00 registration fee is non-refundable once the student attends the first day of class. If a student never reports for their Program (no show) or withdraws before the first day of class, they are considered a cancellation and will receive a refund of the registration fee.

Students are to pay for half of their tuition at the start of their class if their classes total over \$5,000.00. The remainder of tuition is due at the halfway mark of their classes. If a student withdraws voluntarily from the program, tuition fees will be refunded as follows: Before the start of classes, 100% and 75% if the student withdraws during the first 25% of classes.

Withdrawal from a program may be requested by the student at any time during their program. The request to withdraw should be submitted verbally or in writing to the Office Manager.

Tarheel Canine Training, Inc. will notify a student by certified mail if he/she is being administratively withdrawn from their program.

If a student is dismissed from the program by the instructor or the president because of conduct, the tuition fees are non-refundable.

Students may request a refund due to illness or injury by requesting a refund in writing. These will be reviewed on a case-by-case basis by the President. If a refund is issued, it will be 25-50% of the original tuition fee if after the first 25% of the class period. If a refund is issued, it will be sent to the student within forty-five (45) business days of the receipt of the written request.
